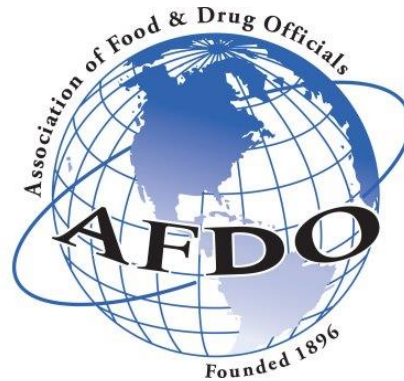

The Association of Food and Drug Officials (AFDO), established in 1896, successfully fosters uniformity in the adoption and enforcement of science-based food, drug, medical devices, cosmetics and product safety laws, rules, and regulations.

AFDO is an international, non-profit organization that is in the forefront of streamlining and simplifying regulations by either drafting regulatory rules or by commenting on government proposals.

The consensus that AFDO develops is key to advancing uniform laws, regulations, and guidelines that result in more efficient regulation and less confusion among industry in the marketplace.

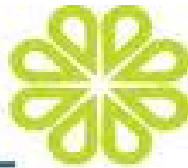

Agreement Name	Amount	Duration
Funding System in Support of Voluntary National Retail Food Regulatory Program Standards	\$2,420,000 per year	5 years (September 1, 2016-August 31, 2021)
Funding System to Support Milk and Shellfish Programs	\$900,000 per year	3 years (September 1, 2016-August 31, 2019)
Continuing to Support, Refine, and Build the Manufactured Food Regulatory Program Alliance (MFRPA) as part of an Integrated Food Safety System (IFSS)	\$2,943,750 per year	5 years (September 1, 2016-June 30, 2021)

AFDO Areas of Emphasis 2016-17

1. Promote and facilitate a move toward greater harmonization between the retail and manufactured program standards
2. Improve the process of identifying and mentoring new program managers
3. Work to bring additional states into AFDO through outreach, invitations, and encouragement.
4. Work to promote greater collaboration and cooperation related to retail food program.
5. Improve the communication of accomplishments of AFDO and its members.

1. Update AFDO Model Food Salvage Code (Administration)
2. Complete model guidance for shared kitchens (Food)
3. Review and Update Food Emergency Pocket Guide (Food Protection and Defense)
4. Review and Update uniform state Food, Drug and Cosmetics Act (Laws and Regulations)
5. Coordinate a salary survey of state food safety program about food safety positions (Professional Development)
6. Update Retail Meat and Poultry Processing Guidelines (Retail Food)
7. Create guidance document on Wild Harvested Mushrooms (Retail Food)
