Building an Integrated Laboratory System to Advance the Safety of Food and Animal (APHL/AAFCO/AFDO) – Key Projects

- Governmental Food and Feed Laboratories Annual Meeting, February 1-4, 2016, Louisville, KY
- Completing competencies and course blueprints for Governmental Laboratory Food and Feed Curriculum Framework entry level foundational courses

Voluntary National Retail Food Regulatory Program Standards (VNRFRPS)

- Accepting Applications 09/01/15-10/09/15
- Open to state, local, territorial, and tribal regulatory retail food programs that have enrolled in the Retail Program Standards
- Year 3 funds available \$1,974,242 (up from \$502,500 in Year 2)
- Years 1 and/or 2 recipients are eligible to apply once again for funds in Year 3
- Notifications 11/20/2015



FDA Food Code Tracking Contract

- Prepare research reports on the status of laws, rules and regulations in all states and territories and consistency with FDA Food Code related to,
 - Requirements for consumer advisories for raw and undercooked animal foods
 - Requirements for no bare hand contact with Ready to Eat Foods
 - Cottage Food production, sale and distribution requirements
